Summary/Matter for Consideration:

Council is required to annually complete a Compliance Audit Return and submit it to the Local Government Department.

Background:

Regulation 14 of the Local Government (Audit) Regulations 1996 sub regulation (3A) requires the Audit Committee to review the Compliance Audit return prior to its submission to Council. This year the return was completed in-house.

Comment:

The following breaches were identified:

- 1. In relation to the disclosure of interest, there was one instance of a member disclosing an interest and not leaving the room.
- 2. Names were not removed from registers after people ceased to be a person required to make a disclosure. Corrected in March 2023
- 3. Audit report was not received by the Local Government before 31 December. The audit was discussed with the auditor at the audit exit meeting, however the report was formally presented to Council in January 2023.
- 4. Regulation 17 review was started but not completed before 31 December 2022. Report will be presented to April 2023 meeting.
- 5. Consolidated value of vehicles purchased from a single supplier exceeded tender threshold value. CEO has counselled staff involved, it should be noted that no other supplier was able to meet required timeframes.
- 6. Details of winning tender were not provided to unsuccessful tenderers.

Statutory Environment:

Regulation 14 & 15 of the Local Government (Audit) Regulations 1996

14. Compliance audits by local governments

(1) A local government is to carry out a compliance audit for the period 1 January to 31 December in each year.

(2) After carrying out a compliance audit the local government is to prepare a compliance audit return in a form approved by the Minister.

(3A) The local government's audit committee is to review the compliance audit return and is to report to the council the results of that review.

(3) After the audit committee has reported to the council under subregulation (3A), the compliance audit return is to be -

(a) presented to the council at a meeting of the council; and

(b) adopted by the council; and

(c)recorded in the minutes of the meeting at which it is adopted.

15. Certified copy of compliance audit return and other documents to be given to Departmental CEO

(1) After the compliance audit return has been presented to the council in accordance with regulation 14(3) a certified copy of the return together with —

(a) a copy of the relevant section of the minutes referred to in regulation 14(3)(c); and

(b) any additional information explaining or qualifying the compliance audit,

is to be submitted to the Departmental CEO by 31 March next following the period to which the return relates.

(2) In this regulation —

certified in relation to a compliance audit return means signed by —

(a) the mayor or president; and

(b)the CEO.
