9.1.3 AIRPORT MANAGER'S REPORT – SEPTEMBER 2024

Aircraft Movements and Statistics

General aviation, Charter & RPT service movements for September 2024 were on par with September 2023. JETA1 sales were slightly lower in comparison to the same period of 2023. AVGAS sales were considerably higher of September compared to 2023 with Avgas drum sales to pastoralists & aviation survey companies making up 57% of total Avgas sales.

As per current trend there continues to be a significant decrease in Royal Flying Doctor Service aircraft movements compared to the same period in 2023. The reasons for decline in RFDS movements through Meekatharra are not known?

Aerodrome Works:

Aerodrome works for the month include:

Bird/Animal Activity:

Bird & Animal activity around the Meekatharra aerodrome has remained a low risk.

General:

CASA approval of the aerodrome manual version 3 review is currently pending notification. Contact from CASA was received during August with reference to the review. Given the review by CASA has been pending for 3 years & 6 months, referral to our aerodrome consultant has been undertaken to ensure our aerodrome manual version 3 now meets the most current aviation regulations. Due to a backlog of aerodromes pending review by CASA it is expected our manual will be confirmed in early October 2024.

CASA advised an aerodrome inspector will conduct an aerodrome site inspection in early October 2024. The last CASA aerodrome inspection of the Meekatharra aerodrome occurred in February 2020.

An aerodrome emergency exercise was held on Saturday 14th September 2024 to test the aerodromes emergency response plans and preparedness for emergencies at the aerodrome. The exercise was well attended by the local emergency services and was well executed. A number of local residents volunteered to represent injured passengers on an aircraft during the emergency.

Westgold Mining will reduce their current aircraft charter flights to Meekatharra from 4 per week to 3 per week, removing the Wednesday afternoon flight from 04/09/24.

There is potential for a new mine startup in the shire (Meeka Metals) to commence aircraft charter operations through the Meekatharra airport from November/December 2024.

9.1.4 RANGERS REPORT – SEPTEMBER 2024

3-4 September 2024

Complaints Received:

No new written or verbal complaints were received since the previous visit.

Animals Trapped:

Trapping was conducted at various locations around town including near the school and the industrial area. Three feral cats were caught.

Animals Destroyed:

Three feral cats were destroyed

Further Patrols:

Patrols were conducted of Peace Gorge, Town Oval, Rubbish Tip, Railway Dam, recreational facilities and surrounding areas. Patrols were also conducted at the Hot Rod track, airport, cemetery, and racetrack, around the school, school oval and around town. Patrols and security checks were conducted around town at various times. It appears that someone has tried to force entry to the white sea container. They had tried to pry the doors open. The DCEO was advised of this issue.

Whilst conducting a security check at the Golf Club, I noticed a set of keys in the main entrance door. I pulled on the door and found the door was closed but not locked. I opened the door and had a quick walk through, and it appears that no one had been inside the building. No damage was visible. I locked and secured the building. I then noticed the two locks at the rear of the building appeared to have been tampered with.

19 – 20 September 2024

Complaints Received:

Two complaints regarding the same issue were received – dogs wandering at large at the Meekatharra Caravan Park. The dogs had been videoed and photographed on a previous visit. A third complaint was received regarding an alleged dog attack. With the assistance of local police, three large dogs were caught whilst wandering at large and taken to the Meekatharra Pound. One dog couldn't be caught and had returned to the property where it lives. The owner of the dogs was contacted. She asked for all the dogs to be removed by the ranger as she and her mother no longer wanted the dogs. A fourth complaint was received regarding another wandering dog. The dog was identified but no further action was taken.

NOTES TO THE STATEMENT OF FINANCIAL ACTIVITY FOR THE PERIOD ENDED 30 SEPTEMBER 2024

1 BASIS OF PREPARATION AND MATERIAL ACCOUNTING POLICIES

BASIS OF PREPARATION

The financial report of the Shire of Meekatharra which is a Class 3 local government comprises general purpose financial statements which have been prepared in accordance with the *Local Government Act 1995* and accompanying regulations.

Local Government Act 1995 requirements

Section 6.4(2) of the *Local Government Act 1995* read with the *Local Government (Financial Management) Regulations 1996* prescribe that the financial report be prepared in accordance with the *Local Government Act 1995* and, to the extent that they are not inconsistent with the Act, the Australian Accounting Standards. The Australian Accounting Standards (as they apply to local governments and not-forprofit entities) and Interpretations of the Australian Accounting Standards Board were applied except for disclosure requirements of:

- AASB 7 Financial Instruments Disclosures
- AASB 16 Leases paragraph 58
- AASB 101 Presentation of Financial Statements paragraph 61
- AASB 116 Property, Plant and Equipment paragraph 79
- AASB 137 Provisions, Contingent Liabilities and Contingent Assets paragraph 85
- · AASB 140 Investment Property paragraph 75(f)
- AASB 1052 Disaggregated Disclosures paragraph 11
- · AASB 1054 Australian Additional Disclosures paragraph 16

The Local Government (Financial Management) Regulations 1996 specify that vested land is a right-of-use asset to be measured at cost, and is considered a zero cost concessionary lease. All right-of-use assets under zero cost concessionary leases are measured at zero cost rather than at fair value, except for vested improvements on concessionary land leases such as roads, buildings or other infrastructure which continue to be reported at fair value, as opposed to the vested land which is measured at zero cost. The measurement of vested improvements at fair value is a departure from AASB 16 which would have required the Shire to measure any vested improvements at zero cost.

Accounting policies which have been adopted in the preparation of this financial report have been consistently applied unless stated otherwise. Except for cash flow and rate setting information, the financial report has been prepared on the accrual basis and is based on historical costs, modified, where applicable, by the measurement at fair value of selected non-current assets, financial assets and liabilities.

Critical accounting estimates and judgements

The preparation of a financial report in conformity with Australian Accounting Standards requires management to make judgements, estimates and assumptions that effect the application of policies and reported amounts of assets and liabilities, income and expenses.

The estimates and associated assumptions are based on historical experience and various other factors that are believed to be reasonable under the circumstances; the results of which form the basis of making the judgements about carrying values of assets and liabilities that are not readily apparent from other sources. Actual results may differ from these estimates.

As with all estimates, the use of different assumptions could lead to material changes in the amounts reported in the financial report.

The following are estimates and assumptions that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year and further information on their nature and impact can be found in the relevant note:

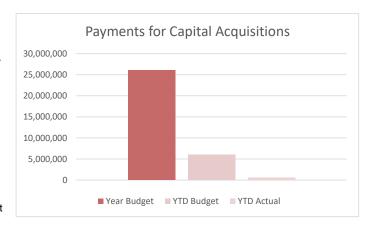
Assets for which the fair value as at the date of acquisition is under \$5,000 are not recognised as an asset in accordance with Financial Management Regulation 17A (5). These assets are expensed immediately.

Where multiple individual low value assets are purchased together as part of a larger asset or collectively forming a larger asset exceeding the threshold, the individual assets are recognised as one asset and capitalised.

Initial recognition and measurement for assets held at cost Plant and equipment including furniture and equipment is recognised at cost on acquisition in accordance with *Financial Management Regulation 17A*. Where acquired at no cost the asset is initially recognise at fair value. Assets held at cost are depreciated and assessed for impairment annually.

Initial recognition and measurement between mandatory revaluation dates for assets held at fair value

In relation to this initial measurement, cost is determined as the fair value of the assets given as consideration plus costs incidental to the acquisition. For assets acquired at zero cost or otherwise significantly less than fair value, cost is determined as fair value at the date of acquisition. The cost of non-current assets constructed by the Shire includes the cost of all materials used in construction, direct labour on the project and an appropriate proportion of variable and fixed overheads.

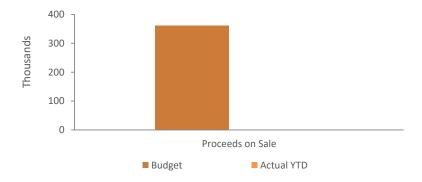

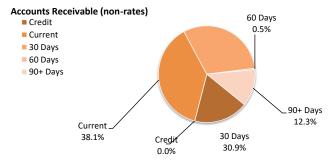

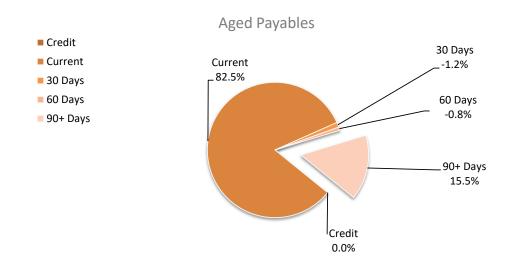

Provision is made for the Shire's obligations for short-term employee benefits. Short-term employee benefits are benefits (other than termination benefits) that are expected to be settled wholly before 12 months after the end of the annual reporting period in which the employees render the related service, including wages, salaries and sick leave. Short-term employee benefits are measured at the (undiscounted) amounts expected to be paid when the obligation is settled.

The Shire's obligations for short-term employee benefits such as wages, salaries and sick leave are recognised as a part of current trade and other payables in the calculation of net current assets.

Other long-term employee benefits

The Shire's obligations for employees' annual leave and long service leave entitlements are recognised as employee related provisions in the statement of financial position.

Long-term employee benefits are measured at the present value of the expected future payments to be made to employees. Expected future payments incorporate anticipated future wage and salary levels, durations of service and employee departures and are discounted at rates determined by reference to market yields at the end of the reporting period on government bonds that have maturity dates that approximate the terms of the obligations. Any remeasurements for changes in assumptions of obligations for other long-term employee benefits are recognised in profit or loss in the periods in which the changes occur. The Shire's obligations for long-term employee benefits are presented as non-current provisions in its statement of financial position, except where the Shire does not have an unconditional right to defer settlement for at least 12 months after the end of the reporting period, in which case the obligations are presented as current provisions.
