# **Background**

The Council at its September meeting made the decision to delegate authority to the Works Group to determine the successful tender for the Flood Damage works. However the Acting CEO discovered after the meeting that the Works Group is not a formally established Committee and therefore the Works Group cannot determine the tender. Council's previous decision therefore is required to be rescinded.
